# New Special Needs Chapter Program

In celebration of Catholic Financial Life's 150-year history of helping families remain strong and secure, and our longstanding tradition of supporting members with special needs and their families, the Society will launch a new Match Fund program beginning January 1, 2019.

This two-year pilot project, called the Special Needs Chapter Program, will provide up to \$500 annually in additional Match Funds to chapters that sponsor a fundraising activity benefiting a member or family of a member with special needs, or a group that supports those with special needs or their caregivers. This will not replace the \$500 in Match Fund support for the Society of St. Vincent de Paul, but will offer an extra \$500 in Match Funds to your chapter. ## Thanks for Your Feedback!



Delegates to the Triennial Convention were asked to complete a survey providing valuable feedback on various aspects of their overall Convention experience. Attendees rated things such as ease of travel, quality of food and lodging, speakers and entertainers, and the registration process. 236 surveys, from nearly 70% of the delegates, were returned and tabulated, and we're happy to report that the feedback has been overwhelmingly positive! In nearly all areas 90% of delegates rated the Convention very good or excellent.

Two highlights for our delegates were the presentation from Special Olympics on Saturday afternoon and Dr. Ronan Tynan's spectacular evening performance. The content and format of the State of the Society session, the other speakers and entertainers, Mass, the transportation provided (shuttles/wheelchairs) and registration process also received high marks from delegates.

It takes months of planning and a crew of people to arrange all of the details involved with the Convention. We're pleased that our delegates and guests had such a positive experience!

It is with mixed emotions that we bid adieu to our good friend, colleague, and Vice President of Member

Engagement at Catholic Financial Life, Joe Gadbois. Joe's career spans 41+ years and three societies: Union Saint-Jean-Baptiste from 1977 to 1991, Catholic Family Life Insurance from 1991-2010, and Catholic Financial Life from 2010-present.

After graduating with a BA in English from College of the Holy Cross, Joe earned an MS in Journalism, Advertising from Northwestern University. He spent the first years of his career at an ad agency in his hometown of Worcester, Massachusetts, before being recruited as Vice President of Communications for Union Saint-Jean-Baptiste. Joe and his family moved from New England to Milwaukee in 1995, when he became Vice President of Fraternal and Marketing for Catholic Family Life Insurance. Joe was also instrumental in the subsequent merger of Catholic Family Life Insurance with Catholic Knights, which became Catholic Financial Life.

## Chowder and Clam Cakes

In the second installment of our "Chapter Fund-Raising Foods" we travel to New England where many meals come from the bounty of the sea. One such food that is a popular basis for chapter fund raisers is "chowder and clam cakes."

First, let's tackle the concept of a clam cake. It is NOT a clam patty. The quintessential clam cake is a deep fried ball-shaped mixture containing chopped clam (usually quahog, Rhode Island's official state bivalve) combined with various other ingredients to give it a firm consistency once fried. The batter is made from flour, milk, clam juice, eggs and a leavening agent, typically baking powder. Crispy, golden brown on the outside, it is pillow-soft and light on the inside.

Now let's consider the chowder - or "chowdah" to New Englanders! In most of the six-state region there is only one kind of clam chowder - white! It's made with milk and cream! End of story! That red tomatochoked stuff is called "Manhattan" - as in New York City - and will never find its way

on the table of any Red Sox fan – which is nearly everyone in New England.

There is one exception. In the "Biggest Little State in the Union" there is a reddish clam chowder called "Rhode Island Chowder." At restaurants in Little Rhody one may ask for white chowder (New England) or red chowder (Rhode Island). The chowder is made with lots of clams in a tomato broth, potatoes and onions. It's like New England chowder without the milk. Unlike the Manhattan, the Rhode Island version has no chunks of tomatoes and no other vegetables.

Though there are many New England chapters that sponsor chowder and clam

cake dinners; one of those is Chapter N052 Danielson, Connecticut. Sue Griffiths, president, reports that the chapter defaults to hiring the expert, Mickey G.'s, who also prepares the same meal for patrons at the Society's September Pilgrimage to the Shrine of Our Lady of La Salette in Massachusetts.

As a fund raiser for St. James Parish and School, the chapter holds the event on Good Friday each year. Last year's was the most successful ever with 160 attending the Friday evening dinner following the afternoon service. The meal cost to attendees is minimal at \$10.00 and over the past decade enough has been raised, and matched, to help build a "crying room" in the church as well as support sacristy renovations, rectory plumbing improvements, and convent upgrades. Assisting the chapter members in serving the meal are eighth grade school students and parishioners.

But in particular it has significantly simplified the year-end reporting process. If your chapter hasn't begun using the FDS, contact Member Engagement to learn how you can sign-up for this great tool!
- We'd like to inform chapters of a slight change for next year. Rather than automatically shipping a small quantity of 50-year rosaries and 25-year ornaments to chapters in January, we are asking that you contact us at least two weeks before your member celebration event to let us know exactly how many you will need, along with any 75-year statues.
